IF THIS HAPPENS	DO THIS						
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call emergency services: Dial 111						
Spill or leak	Wear PVC overalls, chemical resistant gloves, facemask or goggles. Prevent further spillage. Sweep up solids without causing dust. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal. Report large spills to Emergency Services at 0800 CHEMCALL (0800 243 622)						
Fire	Call the Fire Service: Dial 111. Wear PVC protective clothing and breathing apparatus. Fumes and combustion products produced in a fire may be toxic and/or irritating. Small Fire: Use dry chemical, CO ₂ , water spray or foam. Large fire: Use water fog, foam, or dry agent. If safe to do so, move undamaged containers from fire area. Cool container with flooding quantities of water until well after fire is out. Contain run-off. Keep non-involved persons away.						
FIRST AID							
If Swallowed:	Do not induce vomiting. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.						
If in Eyes:	Flush eyes thoroughly with running water for 15 minutes. Remove contact lenses. If effects continue, consult a doctor or the National Poisons Centre 0800 POISON (0800 764 766)						
If on Skin:	Remove contaminated clothing and flush skin with running water. Do not scrub the skin.						
If Inhaled:	If safe to do so, remove patient to fresh air. If not breathing, give artificial respiration, preferably mouth-to-nose. Get medical attention if symptoms develop.

Storage: Store in tightly closed original container in a cool, dry well-ventilated area out of direct sunlight when not in use. This product can be stored in an unheated building.
